A change in legislation has paved the way for pharmacy technicians to provide services using PGD's and the Pharmacy First service continues to gather pace. Newly qualified pharmacists

CPPE is here to support you right from the start of your career. We have an extensive portfolio of learning for all areas of practice. A key programme to support you is the Newly Qualified Pharmacist Programme

The overall aim of the Newly qualified pharmacist programme is to support newly qualified pharmacists to develop, and demonstrate, confidence and competence in core areas of pharmacy practice. The programme is designed to support pharmacists to become better equipped to adapt and deliver safe and effective patient care and overcome the challenges of this new stage of your career. The 12-month programme, fully funded by NHS England as part of their Newly Qualified Pharmacist pathway, takes a blended learning approach, offering a mix of online learning, workshops, assessment and work-based support through a designated CPPE education supervisor.

The programme includes the following online modules:

- Module 1: Person centred care and collaboration
- Module 2: Clinical knowledge, skills and decision making
- Module 3: Leadership and management
- Module 4: Education and research
- Module 5: Preparing to train as an independent prescriber

Primary Care Pharmacy Education Pathway (PCPEP)

CPPE's <u>Primary Care Pharmacy Education Pathway</u> has supported over 17,000 pharmacy professionals working in Primary Care Networks in Additional Roles Reimbursement Scheme (ARRS) roles. Developing skills and knowledge to support enhanced work and the long-term vision of the NHS.

The programme is 15 months for pharmacy technicians and 18 months for pharmacists and consists for five modules

- Module 1 foundation (introduction to primary care, structured medication reviews, consultation skills and clinical assessment skills)
- Module 2 enhancing clinical knowledge (five complex cases over six months covering a large range of clinical topics)
- Module 3 Clinical assessment skills (developing skills such as taking manual and automated blood pressure, respiratory rate, pulse, oxygen saturation and temperature)
- Module 4 Leadership (leadership learning and quality improvement project development)
- Module 5 Building on skills and knowledge from previous modules



Places are now available for pharmacy professionals working in GP practice and care homes that are not funded by ARRS, the Health and Justice sector and Armed Forces. Cohort 18 starts January 2025, apply via PCPEP Applications

Community pharmacy technician: advancing your role

The <u>Community pharmacy technician: advancing your role</u> programme has been launched in collaboration with the Pharmacy Integration Programme at NHS England has recently had the application window extended. The fully funded learning programme is designed to help community pharmacy technicians develop the skills and confidence to deliver effective clinical services in community pharmacy. Pharmacy technicians who currently work in community pharmacy and are looking to upskill themselves to develop their roles in practice can apply to take part.

The different topic areas in this programme will support pharmacy technicians to demonstrate appropriate clinical assessment skills and apply them to practice, to apply the essential knowledge and skills required to deliver highly effective clinical services in community pharmacy, and to apply relevant clinical therapeutics to person-centred consultations, ensuring that shared decision making is prioritised.

The programme consists of the following components:

• Four-month self-directed e-course comprised of six modules

- Learning needs assessment (LNA) at start of programme
- Initial meeting with an education supervisor to discuss learning needs and form an action plan
- Approximately 4-6 hours of learning per week
- One face-to-face workshop on clinical assessment skills (CAS)
- Workplace practice of CAS to be signed off in practice
- · Mandatory two-hour evening workshop for reflection in month four
- Optional monthly one-hour peer support sessions



Accuracy Checking Pharmacy Technician programme

CPPE have an <u>Accuracy Checking Pharmacy Technician programme</u> available to all areas of practice where pharmacy technicians have access to a dispensary. The programme includes online learning modules alongside work-based support and assessment. Pharmacy technicians will be supported by a work-based education supervisor and a CPPE tutor. The course aligns with APTUK National Education Framework for the Final Accuracy Checking of Dispensed Medicines and Products. The course has been designed to be completed in a minimum of three months and a maximum of twelve months with the main aims of the programme being:

- develop the skills required to be a safe final accuracy checking pharmacy technician
- improve leadership skills to direct the dispensary team
- support the multi-disciplinary team to deliver patient-facing services. For more information, fees and registration visit Accuracy checking pharmacy technician programme : CPPE

Ten NHS England funded places will be available every month (from the 1st of every month) or the option to pay for a place is also available.



This programme supports pharmacy technicians to develop the confidence to work under patient group directions (PGDs). It provides examples of opportunities to use PGDs in practice and uses activities that aim to empower pharmacy technicians to work under PGDs to increase capacity for person-centred care within the healthcare team.

Leadership

Chief Pharmaceutical Officer's Pharmacy leaders development programme

The <u>Chief Pharmaceutical Officer's Pharmacy leaders development programme</u> is for experienced pharmacists and pharmacy technicians who aspire to lead large and complex NHS departments, services, teams or systems of care to benefit patients and local communities. It aims to develop the knowledge, skills, attitudes and behaviours to help experienced pharmacy professionals become outstanding, compassionate and inclusive leaders, and improve the performance of the teams and the people who work with them to deliver improved outcomes for patients and the public. A key objective is to make a positive contribution to improving the diversity of those in senior pharmacy professional leadership positions in the NHS.

The programme has two themes that run throughout: a focus on the 'line of sight' to the quality and experience of those who access health and care services; and a commitment to embed excellence in equality, diversity, and inclusion within all aspects of leadership. The programme offers a comprehensive mix of residential workshops (nine months apart), optional online specialist study days, and small group support to build capability, confidence, and networks across the wider system.

The closing date for applications to join Cohort 8 will be midday on Monday 16 December 2024

Pharmacy Technicians

Pharmacy technician impact groups

<u>CPPE Pharmacy technician impact groups</u> are a series of small group sessions for pharmacy technicians who would like to develop their skills and confidence further. They are designed to complement CPPE's <u>Pharmacy technician enhancing your professional practice</u> e-course.

Each Impact group session runs from 9.30am to 2.30pm with six sessions in total running on the same day of the week roughly every eight weeks.

The impact groups aim to give pharmacy technicians a space to network across sectors and share best practices.

Prepare to train as an independent prescriber



The CPPE Preparing to train as an independent prescriber programme is open to pharmacists from all sectors of practice, including community pharmacists who are planning to commence their independent prescriber training with a Higher Education Institute (HEI). This is a fully funded course that helps pharmacists develop the skills and confidence to get ready and best prepare for independent prescriber training.

Return to Prescribing

If you are already an independent prescriber, but have had a break in prescribing practice, you may feel you need some support to restart this role. The CPPE Return to prescribing programme is open to any pharmacist prescriber registered in England who needs to regain the competence and confidence to prescribe. The programme runs over a three month period with three interactive online workshops.

Extending the scope of prescribing practice

The CPPE Extending the scope of prescribing practice e-learning programme focuses on extending prescribing practice; so is aimed at pharmacists who are currently prescribing and are familiar with the underlying principles and guidance relating to prescribing.

The programme covers the key principles to consider when extending your scope of prescribing practice including reflection, peer review, assurance of competence and prescribing governance to support your approach to the learning and development of new clinical skills and expertise.

Trainee pharmacists

The CPPE guide to your foundation training year, lists CPPE and key external resources to support you in areas of high weighting (page 11 of the guide).

Often in practice you may encounter conditions that highlight a knowledge gap. CPPE have a range of clinical factsheets to support you with up-to-date clinical information.
