Post Event Messaging ACTION	Contractual	30th September 2024	NHS England has sent out a further cascade message to NHS pharmacy teams regarding post event messages on <b>PharmOutcomes</b> .  The new cascade message highlights the actions that pharmacy owners who use or have used PharmOutcomes, in the past must take if they have a queue of notification emails within PharmOutcomes for clinical services provided by the pharmacy. <b>Further information – Click here</b>

This means you have to provide a minimum of 30 consultations that pass the gateway point to be eligible for the £1,000 monthly payment. Flu Vaccinations/ COVID-19	Services	3 <sup>rd</sup> October 2024	Flu vaccinations of <b>all eligible groups</b> can start under the 2024/25 Flu Vaccination Service (pregnant women could be vaccinated from 1 <sup>st</sup> September 2024).  Vaccination of <b>all eligible groups</b> can start under the autumn/winter 2024/25 COVID-19 Vaccination Service
